AUTHORIZATION FOR SALE OF CHOMETZ - 5770

I hereby authorize Rabbi Shlomo Hochberg to sell my Chometz (including actual Chometz, Chometz mixtures, and uncertain Chometz mixtures), including those stocks, bonds or corporate partnerships which deal with Chometz, and to sell or rent the rooms, space, closets or containers (but not utensils) in which the Chometz may be found, to any non-Jew whom he will choose, in accordance with all the requirements of Jewish law as incorporated in the special contract for the Sale of Chometz, and in accordance with local, state and federal law. I also grant Rabbi Hochberg full authority to appoint a substitute to sell the Chometz in his stead as he may see fit. ***This sale will take place on Monday, March 29 at about 11:00 AM.*** There will be an earlier separate sale on Sunday afternoon (at about 3:00 PM) for those who will be in Israel or Europe.

I have listed below the location of the Chometz as specifically as possible, and include in the sale any other Chometz owned by me at any other location. The Chometz will be accessible to the non-Jew purchasing the Chometz, should he/she wish to move it from its present location. This authorization is made binding by my signature below, and shall be considered as if I had actually signed the Bill of Sale.
